Respected Sir,

I, Pranav Gupta S/o Late Sh. Vijay Kumar Gupta is residing at E GK-1, New Delhi. I am lodging the present complaint with utmost urgency and concern regarding the illegal conduct of Inspector Ganpati Maharaj, DIU South District while handling the case bearing FIR No. 215/2025, PS GK1, which is registered on the complaint of my wife against myself and my family members.


That while handling the said case Inspector Ganpati Maharaj has on several occasions demanded gratification / bribe from me. For instance, on 16.08.2025, during the investigation of aforesaid case which is conducted by Inspector Ganpati Maharaj, I was explicitly asked to pay a bribe amounting Rs. 25,00,000/for Inspector Ganpati Maharaj himself and he also demanded another amount of Rs. 20,00,000/- for DCP Ankit Chauhan, DCP South, Delhi Police. Since I did not fulfil the said illegal demands of Inspector Ganpati Mahraj, the aforesaid illegal demand was followed by intense and highly stressful interrogation, leaving me panic-stricken and deeply fearful. Upon leaving the investigation premises, I immediately contacted my advocate, Mr. Sanjay Sehgal, who advised me to remain calm and assured me he would address this blatant misconduct.

That after the above incidence Inspector Ganpati Maharaj continued to harass me through repeated WhatsApp calls and the detail of this Whats App calls with date and time are as below,

The above-mentioned calls were intimidating, coercive and created undue pressure, affecting my mental and emotional well-being.

That it is pertinent to mention that during the investigation of said case on 16.08.2025, it became evident that Inspector Ganpati Maharaj is in constant communication with the father of complainant namely Mr. Rakesh Gupta. That it is pertinent to mention that all the six accused in the above matter had preferred anticipatory bail. On 02.08.2025, the Hon'ble court of Shri Lalit Kumar, ASJ (FTC)-01, South-East District, Saket Courts, New Delhi referred the matter to the Mediation Centre and granted interim protection, directing that no coercive action be taken against the accused until the next hearing. The bail applications were kept pending with the next mediation scheduled for 22.09.2025 and the bail hearing were listed for 25.09.2025 before the Hon'ble Court. Despite the aforesaid directions and pendency of settlement talks Inspector Ganpati Maharaj is putting undue pressure upon me. It is a standard practice that during ongoing mediation, investigating agencies encourage settlement discussions rather than exert coercive pressure. However, in this case, Inspector Ganpati Maharaj has created undue harassment and pressure, disregarded judicial protections and threatened my family. This conduct is highly irregular and unjustified, especially given the ongoing judicial proceedings.

That to ensure that the investigation of aforesaid case is conducted fairly and transparently, I request the following information to be provided:

- (a) Number of FIRs U/s 498A/406 transferred from various police stations of South District to DIU during April 2025 to August 2025.
- (b) Total number of complaints received by the CAW Cell, South District from January 2025 to April 2025.
- (c) Number of complaints settled or mediated to date for complaints filed during the above period.
- (d) Number of complaints forwarded for registration of an FIR.
- (e) Number of complaints still pending with the CAW Cell from the above period.

That the aforesaid data will ensure transparency and accountability and provide a clearer picture of case-handling trends. Furthermore, thorough examination of all WhatsApp and call records, communications may kindly be done to collect evidence of undue influence exerted by complainant's father Mr. Rakesh Gupta and Inspector Ganpati Maharaj.

That I am prepared to cooperate with the Investigating Agency and provide all relevant evidence, including WhatsApp call logs, communications, and documentation to support this complaint.

That in view of the aforesaid facts and circumstances, it is requested that Inspector Ganpati Maharaj may kindly be removed from this investigation due to misconduct, harassment, and extortion attempts and thereafter the said case may be assigned to a neutral and unbiased officer to ensure the investigation proceeds fairly, transparently, and without undue influence.

That I sincerely urge your good office to take immediate action to prevent further harassment, ensure accountability & restore faith in investigative process.
